

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.ChickenShack.com](http://www.ChickenShack.com) and Chicken Shack and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Chicken Shack include [www.ChickenShack.com](http://www.ChickenShack.com). The Chicken Shack website is a Restaurant site. By using the Chicken Shack website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Chicken Shack may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

Chicken Shack may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. ## Sharing Information with Third Parties

Chicken Shack does not sell, rent or lease its customer lists to third parties.

Chicken Shack may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Chicken

Shack, and they are required to maintain the confidentiality of your information.

### **Tracking User Behavior**

### **Security of your Personal Information**

- SSL Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. - Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity; or prosecute those responsible for that activity;
- Debug to identify and repair errors that impair existing intended functionality;
- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
